

EULiST EARLY CAREER RESEARCHERS' MOBILITY – Rules for PhD Student Mobilities in 2025

A call for applications for early career researcher mobility within the EULiST alliance has been announced and is available on the alliance website: <https://eulist.university/mobility-for-ecrs/>

This concerns short-term mobilities of PhD students and postdoctoral researchers to partner universities of the EULiST alliance. The mobility is funded by the sending institution. At Brno University of Technology (BUT), the costs are covered from EULiST funds (WP4).

Conditions for mobilities from BUT – Round 1 (mobilities taking place between September–December 2025)

- **Target group:** PhD students only
- **Type of support:** Mobility scholarship of CZK 20,000/month
- **Maximum stay duration:** 3 months
- **Funding:** EULiST WP4
- **BUT quota:** 21 mobilities, distributed based on the number of full-time PhD students within the standard study period as of 30 October 2024

- **A mandatory output** of the mobility is a submitted grant proposal or an RDI result (publication, applied result, etc.), or an artistic outcome. This output must be demonstrated by the PhD student within one year of completing the mobility.

Procedure for submitting a mobility application

1. **Contact with host institution:**
The PhD student first contacts the head of the research group listed in the specific mobility offer to verify interest in collaboration.
2. **Submission of proposal to faculty/HE institute (F/HEI):**
If the host institution agrees, the student submits a mobility proposal, motivation letter, and CV to their faculty/HEI (the proposal must include the signature of the PhD supervisor and

the contact person at the host institution – alternatively, this can be replaced by email correspondence).

 **Deadline for submission to F/HEI: 30 June 2025**

3. **Selection by F/HEI:**

If multiple applications are submitted, faculties/HEIs will select candidates based on the benefit of the mobility and the strategic alignment of the topic with BUT priorities.

4. **Candidate nomination:**

Faculties/HEIs send the approved proposals (including CV and motivation letter) to the following address:

 **Deadline: 15 July 2025**

5. **Final report:**

Within one month after the end of the stay, the PhD student submits a final report to the above-mentioned email.

6. **Fulfilment of mandatory output:**

Within 1 year after the end of the mobility, the PhD student must provide evidence of fulfilling the output requirement (see above) to the same email address.
